AfricAid carries out its mission through a joint effort between AfricAid in the U.S., and its sister organization in Tanzania (AfricAid (TZ)). AfricAid (TZ) is a fully independent entity, with its own governing board and staff.

The Kisa Project is a girls' scholarship and leadership training program initiated in 2010 by AfricAid (US) and operated in Tanzania by AfricAid (TZ), AfricAid (US)'s sister organization, an NGO established under Tanzanian laws and regulations, with its own separate board of directors and staff. Until 2016, AfricAid (US) had been the primary funding source of the Kisa Project. As the Kisa Project has grown, grantors are increasingly providing funding directly to AfricAid (TZ), a testament to the strengths, professionalism, and sustainability of its operations. As a result, AfricAid (US) absorbs the majority of the administrative and fundraising costs associated with obtaining funding for AfricAid (TZ), allowing AfricAid (TZ) to devote substantially all of its resources to its programs.

4b (Code:) (Expenses \$ **112,808** including grants of \$ **23,156**) (Revenue \$)

In addition to the Kisa Project, AfricAid (US) supports a number of smaller programs that provide powerful educational opportunities for students in Tanzania. These include the provision of scholarships and sponsorships for students in several schools, both primary and secondary, in both urban and rural settings; the provision of much-needed school supplies; and the funding of an innovative school lunch program for a primary school in a rural Maasai community.

During 2016, approximately \$88,450 in funding was directly received by AfricAid (TZ), primarily as a result of AfricAid (US)'s fundraising efforts and activities. If these funds had been initially received by Africa (US) and then sent to AfricAid (TZ), the program expense to total expense ratio would have increased to 66%.
