AfricAid supports girls' education in Africa through the joint efforts of itself and those of its sister organization in Tanzania (AfricAid (TZ)), a fully independent entity, with its own governing board and staff.

Initiated in 2010, the Kisa Project ("Kisa") is a 2-year girls' mentoring and leadership training program operated in Tanzania by AfricAid (TZ) designed to enable young women to reach their full potential and become catalysts for change. Until 2016, AfricAid (US) had been Kisa's primary funding source. However, as Kisa has grown, grantors are increasingly providing grant funding directly to AfricAid (TZ) for the operations of its programs, with AfricAid (US) absorbing most of the fundraising and administrative costs associated with obtaining such funding. While this trend tends to unfavorably skew AfricAid (US)'s functional expense ratios, it demonstrates the strengths of AfricAid (TZ)'s operations and the confidence that grantors have in the Kisa Project.

4b (Code:) (Expenses \$ **23,514** including grants of \$ **23,514**) (Revenue \$)

Binti Shupavu ("Courageous Daughter" in Swahili) ("Binti"), is AfricAid's newest initiative, a 4-year mentoring program for younger, more vulnerable girls, designed to give them the tools they need to stay in, complete and transition from secondary school to additional education or meaningful employment. It is tailored to specifically address key challenges that lead to hundreds of thousands of Tanzanian girls dropping out of secondary school every year. Like Kisa, since Binti's launch in 2016, it has been increasingly funded by grants made directly to AfricAid (TZ), a trend that AfricAid (US) expects to continue and expand as the Binti program grows.

In addition to the Kisa Project and Binti Shupavu, AfricAid (US) supports a number of smaller programs that provide powerful educational opportunities for students in Tanzania. These include the provision of scholarships and sponsorships for students in several schools, both primary and secondary, in both urban and rural settings; the provision of much-needed school supplies; and the funding of an innovative school lunch program for a primary school in a rural Maasai community.

With funding for AfricAid's programs increasing going directly to AfricAid (TZ), its sister organization in Tanzania, AfricAid(US)'s ratio of program expenses to total expenses continues to decline, as AfricAid(US) absorbs the majority of the fundraising and administrative costs for AfricAid(TZ). During 2017, approximately \$131,500 in funding was directly received by AfricAid(TZ), primarily as a result of AfricAid(US)'s fundraising efforts and activities. If these funds had initially been received by AfricAid(US) and then sent to AfricAid(TZ), the program expense to total expense ratio would have increased to 65%.
