Kisa Project is a two-year leadership course operated in Tanzania by AfricAid TZ that prepares girls in their last two years of secondary school to attend university and create positive social change in their communities. In 2019, 98% of Kisa Scholars continued to university compared to the 3% national average for girls. AfricAid US has historically been Kisa's primary funding source, although grantors have increasingly provided funding directly to AfricAid TZ, which demonstrates the confidence grantors have in our programs. However, AfricAid US absorbs the majority of the fundraising and administrative expenses associated with these grants. While this allows AfricAid TZ to devote substantially more resources toward programs, it unfavorably skews AfricAid US's functional expense ratios.

4b (Code:) (Expenses \$ **243,930** including grants of \$ **243,930**) (Revenue \$)

Binti Shupavu is a four-year life skills course operated in Tanzania by AfricAid TZ for lower secondary school girls covering topics such as study skills, personal leadership, health, and self-confidence. It is tailored to address key challenges that lead to hundreds of thousands of vulnerable girls dropping out of secondary school each year, with the goal of increasing their graduation rates. In 2019, 99% of Binti Scholars graduated from lower secondary school. Like Kisa Project, Binti Shupavu has been partially funded by grants made directly to AfricAid TZ, while AfricAid US absorbs the added costs of fundraising and administration of these grants.

In addition to Kisa Project and Binti Shupavu, AfricAid supports a number of smaller programs that provide educational opportunities for students in Tanzania. AfricAid provides scholarships for students in secondary school and university and funds a school lunch program for a primary school in a rural Maasai community.
